Jeen Li is a partner at AllBright Law Offices in Shanghai. His practice areas include securities and capital markets, corporate, mergers and acquisitions, and private equity.

Mr. Li has handled many projects including IPOs, private offerings, major asset restructurings of listed companies for over ten domestic and overseas companies, acted as legal counsel for several private equity funds and provided legal services for private equity fund raising projects worth more than ten billion RMB.

Mr. Li has served as a member of Securities and Futures Research Committee of the Shanghai Bar Association, the Financial Law Research Commission of Shanghai Law Society, and as a member of the Shanghai Financial Engineering Association.

Mr. Li obtained a masters in engineering and a doctorate in management and financial engineering from Shanghai Jiao Tong University in 1999 and 2002 respectively, and he graduated from the post-doctoral station for legal science in East China University of Political Science and Law in 2009.

In recent years, Mr. Li has published dozens of academic papers covering the fields of economics and law, and published a financial monograph *Term Structure of Interest Rate and Pricing of Fixed-income Securities* (published by China Finance Publishing House in 2005, with its preface written by Mr. Zhu Congjiu, the former General Manager of Shanghai Stock Exchange). He also participated in researching the 11th joint research program of the Shanghai Stock Exchange, named *Influence of the Introduction of QDII on Chinese Securities Market*. He has co-authored a financial paper, entitled *Quantitative Research on the Motivations of Securities Companies and Their Effect* which was awarded third prize for subject research by the China Securities Regulatory Commission (CSRC) in 2002, and a legal program completed under his supervision entitled *Research on Legal Issues Regarding the Development of IP Asset Securitization in China* was awarded second prize by the Shanghai Law Society for subjects completed by young scholars in 2006.
